1. I _____ (Name/Company Name) hereby acknowledge that any photos, pictures, video or other media forms taken at any of the 2021 WORCS events will be used for media purposes only (i.e. magazines, newspaper, social media, etc.). Any photos, pictures, video or other media forms taken will not be sold to the general public at or after any PP event. I also agree to give all rights of the photographs, video or other media taken at any Podium Promotions LLC, (PP) event, the controlling body of WORCS Racing, to be used at PP' discretion.
2. I _____ (Initial) I also hereby acknowledge that I must wear a media vest **AT ALL TIMES** I am working the event. If media personal does not have media vest, PP will provide one for the event weekend. The vest **MUST** be returned at the end of the weekend to PP official or you will be charged a non-return fee of \$20 dollars.
3. I _____ (Initial) herby acknowledge that I am entering a live course at my own risk and I will not place myself in harm's way or that of a racer, spectator, or PP official to obtain a photograph or video.
4. I _____ (Initial) herby acknowledge that I must give the right of way to WORCS' contracted videographer, photographer and WORCS staff at all times and interference, disruption, unprofessional behavior will result in an immediate dismissal from said event.
4. **DRONE OPERATION:** I _____ (Initial) certify that I have a license to operate a drone and that I have drone operator's insurance. (PP official initial here _____ to verify that documentation has been provided.)
5. I _____ (Initial) herby acknowledge that I will not release any photos or videos to any social media platform, or any persons until 7 days have passed from the last day of the last round.

By signing, I _____ (Initial) agree to the above statements and hereby acknowledge that PP events are inherently dangerous, and I have had sufficient experience to understand all the risks involved with PP Events. I understand that there are risks (including serious bodily harm or death) in photographing these live PP events and express to voluntarily assume all risk of personal injury or death sustained while photography PP events, whether or not caused by the negligence or other fault of PP.

I, the undersigned, do herby for myself, my heirs, executors, and assigns, release, remise and forever discharge and agree to indemnify and hold harmless individuals, officers, agents, sponsors, co-sponsors, sanctioning bodies, servants, land owners, vehicle owners, lessees of premises used to conduct the event, employees, from every claim, demand, action of whatsoever kind or nature and any cost, lost or expense in connection therewith arising from or any reason of or on the occasion of any use by, of the Podium Promotions LLC course or related facilities including any claims or demands for injury to, or death of any person or damage to, or destruction of, any property resulting from or claim to result from or arise out of accident or occurrence during or in connection with said use including specifically such as may arise out of or be claimed to arise out of negligence on the part of said Podium Promotions LLC.
